I. General information

How do we use your personal data?

This Privacy Notice explains the way we collect, use, share and protect your personal data. In case of any future changes to this Privacy Notice, we will publish information concerning such changes in a timely manner.

The rights you have with regard to your personal data

Under the Bulgarian legislation you may exercise the following rights related to the processed by FICOSOTA Ltd. personal data:

- to access your personal data, which are being processed by FICOSOTA Ltd. and receive a copy thereof;
- to have your personal data rectified in case of inaccuracy or incompleteness;
- to request erasure of your data, where one of the grounds below applies;
- to request restriction of your personal data processing in the cases provided by law;
- to object to the processing of your personal data in the cases provided by law;
- to exercise your right to data portability and to request that your data are provided in a structured, commonly used and machine-readable format;
- where processing is based on your consent, to withdraw your consent at all times, without having to pay any fees
- to file a complaint to the Commission for Personal Data Protection
